Iridium Australia plans utilise the Iridium geosynchronous, low Earth orbit satellite constellation, in conjunction with compatible Iridium hardware. The Iridium Australia plans are geo-restricted to use on the Australia and New Zealand land masses, as well as an area up to 200 nautical miles from the coast of Australia, and up to 12 nautical miles from the coast of New Zealand.
